eVeReport


eVeReport is a new database combining vigilance and e-health. eVeReport can be used in an autonomously way to track and manage your spontaneous notifications or your cases from clinical studies. eVeReport is also combined with the new e-health tools such as: My eReport Studies, My eClinical and eVeCrawl.

For eVeDrug, there is no difference between clients, but clients have specific needs. Therefore, all our Pharmacovigilance databases are systematically equipped with a workflow system, a module to import cases from Eudravigilance as well as Gateway. It is up to you to use (or not) these functionalities according to your needs and processes. Quality is our priority.

That is why eVeDrug supports you in the validation, of your databases as well as in the efficient management of the Change Control. Our databases allow data management in compliance with Regulation (DPR) n°2016/679, known as the General Data Protection Regulation (GDPR).

2. Spontaneous notification... Spontaneously!



My eReport is a new way to report and track adverse reactions to drugs and other health products*.

My eReport allows anyone (patients, relatives, healthcare professionals) to report an adverse reaction in a simple, fast and secure way from all types of devices (smartphone, tablet...) and from any country (of the European Union).

- My eReport instantly communicates you the email address of the authority receiver who is responsible for recording your statement, and gives you the possibility to send a copy of it to the physician. You also keep a duplicate of all your declarations on your mobile phone.
- My eReport is a free app, configurable in several European languages.

3. Post Marketing Studies – Step 4 Studies

My eReport PM is intended for PASS/PAES studies and allows the escalation in a dedicated/specific database of all cases related to studies initiated after the marketing authorization of a drug.

4. Clinical Studies

My eClinical is intended for any investigator involve in a clinical study who wishes to quickly report an adverse event to the Sponsor from all types of digital media. This system allows to meet the new regulations for clinical trials: real-time, reliable and secure transmissions.

5. Social Media Crawling

A number of adverse reactions are neither reported to the health authorities nor informed to the manufacturers.

On the other hand, discussions on forums and social media provide a wealth of information to better manage the risks associated with health products. **eVeCrawl** allows you to collect data from these sources in order to analyse them effectively according to the country, the language used, their degree of relevance. We are no longer in traditional pharmacovigilance, but in signal detection.

This “pharmaco-surveillance” is one of the way to better manage the Benefit/Risk associated with all health products.
